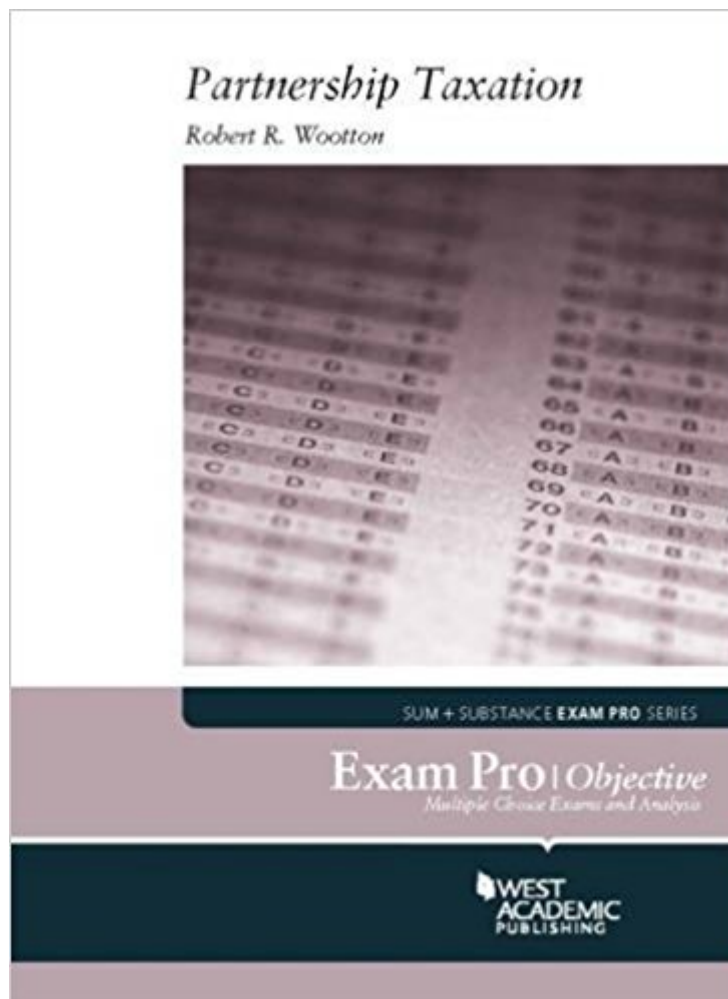

The students in Northwestern Pritzker's LLM Tax Program have named him its outstanding tax professor seven times.
