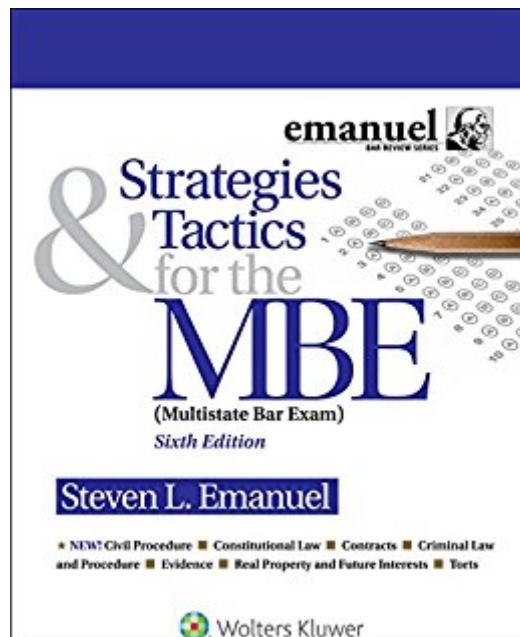

I received this book two days ago and have probably spent about 6-7 hours total with it so far. It is good. It is helpful, and I would recommend it. But, I had to stop, mid-study, to write this review because there are numerous typographical errors. There are some that are normal, that you could easily glance over and it would make no big deal, but there are others that affect the outcome of an answer. Huge confidence blow, and not something you would expect from an \$80 book designed to help you choose correct answers, no matter how long and dense it is.

I used it, passed the bar, so I can't complain. A fair amount of repeat questions from practice questions that my school gave us for free.

I did a Kaplan bar review course, did MBE questions everyday and still failed the New York Bar Exam. Then one of my professors who also teaches for BarBri told me about this book and that he felt it was better than any of the MBE materials that accompanies the bar prep courses. I couldn't agree more. I retook the bar exam in February with Kaplan and I used this book as a supplement towards the end. I was still a little nervous so I used the Kaplan questions during most of my bar prep, so I did not get to do all of the questions in this book. I found the questions in this book to be more representative to the actual MBE questions. My MBE score increased and I passed the Bar. Although this book is amazing and far better than the Kaplan MBE questions, but I would advise you to only use it as supplement to an actual full bar review course. The book works best if you have already studied the subjects before using the book. And you will still need your bar review course for the essay, state multiple choice and MPT portions of the exam. But you should make room in your schedule to do the questions in this book, even if it means replacing it with your bar review course MBE questions towards the end. I am now studying for Florida Bar and I will definitely be using to book.

What is the use of the full practice exam in the back if it contains several inaccurate statements of law in the answer key, and is clearly from such an old exam that it states that the instructions of the

exam make contributory negligence the default rule? For at least 2 decades that has not been the case. The scantron is also a joke. Numbers out of order, repeating, a mess. Plus how rushed could you have possibly been to print such a poorly edited and thought out book that you couldn't take one day to take the extra 100 Q's in the back and move the answers out of the body of the question?

This is a great study tool. It came in good condition and the updates are helpful to bar examiners, the questions are good to help you train with the exam in the back and the prep info before each section. This is a tool for bar passage, I recommend doing these in preparation for those subjects while you are studying them in law school! This product came to me brand spanking new and in wonderful condition. I highly recommend using it.

The book has many similar readings as the previous addition. However, overall this is still a good book.

This book is great for learning how to approach the MBE. In addition, it uses actual questions from past official MBE exams, which is helpful because most of the bar prep classes (minus Adaptibar) use some real questions but also write their own that are way more nuanced and confusing. The explanations to the answers in the practice sets are much easier to understand, and the substantive law review for the civil procedure section helped summarize what my bar prep class taught me. I wish I had bought it a few months sooner!

I highly recommend this book above and beyond a bar review course. I've taken two bar exams in 1995 and 2013 and did not take a bar review course either time. The first time, I was a poor student. I was a BARBRI rep, so I got the books for free as payment, but I skipped the bar review course and only read the outlines. I don't even remember if BARBRI had an MBE book because I used an earlier version of an Emanuel for the MBE. This time, I downloaded outlines on the subjects tested in the jurisdiction where I took the bar and used this Emanuel Strategies & Tactics for the MBE. That's all, no bar course. This book is absolutely critical for the MBE, and an excellent help for essay questions on these subjects too. Bar review courses are completely unnecessary, in my opinion. Spend your money on this book and study it religiously. It streamlines everything--the fact patterns to expect, how to answer questions on each specific subtopic (UCC, option contracts, perfect tender, etc.), why a particular answer is a distractor to mislead you, why a particular answer is

correct, etc. You'll never regret relying on this book as your main study guide!
