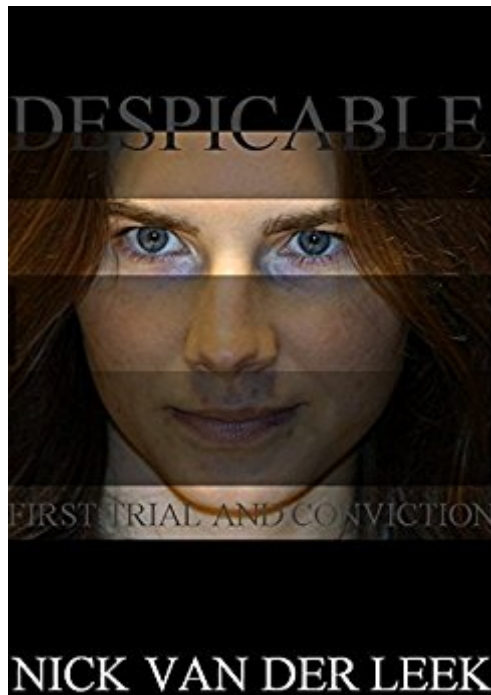

I think he was very fair and showed the strengths and weaknesses of both sides-the defense and prosecution. Please beware of biased reviews with no verified purchase. They are easily recognizable usually including the word "guilter" and "hater", have excessive exclamation points, words in caps lock, and are written in an over-emotional attacking style. My only complaint is that I flew through this and am left wanting more. Great writing and research as always.
